WAIVER AND RELEASE OF LIABILITY

PLEASE READ CAREFULLY. THIS IS A RELEASE OF LIABILITY, ASSUMPTION OF RISK, AND INDEMNITY AGREEMENT.

In consideration of being allowed to participate in any way in any event hosted by **Los Banos Pickleball Club (the “Released Party”)**, I hereby acknowledge and agree as follows:

Assumption of Risk:

I understand that participation in pickleball and related activities involves inherent risk, including, but not limited to, the risk of serious bodily injury, permanent disability, paralysis, death, and/or property damage. These risks may be caused by my own actions or inactions, the actions or inactions of others participating in the event, the conditions of the premises, or the equipment used.

Release and Waiver

I understand that sporting activities present a risk of injury. I certify that I am physically fit and have sufficiently prepared or trained for participation in any event sponsored by **Los Banos Pickleball Club**. I hereby waive and release all claims or causes of action that I may acquire against the **Los Banos Pickleball Club** from any and all liability, claims, demands, losses, or damages arising out of or related to my involvement in any event.

Indemnification

I further agree to defend, indemnify, and hold harmless, the **Released Party** from any and all claims, liabilities, damages, costs, and expenses (including reasonable attorneys’ fees) arising out of or relating to my participation in any event, including claims brought by third parties.

Use of Likeness

I understand that while participating in this event, I may be photographed, filmed, or recorded. I consent to the use of my name, image, and likeness for promotional, advertising, or other legitimate purposes by the **Released Party** without compensation or further notice.

Severability

If any provision of this agreement is found to be unenforceable or invalid, that provision shall be severed, and the remaining provisions shall remain in full force and effect.

Governing Law.

This agreement shall be governed by and construed in accordance with the laws of the State of California.
